We will hold our Swim Team Registration and Kick-off at Greenwyche on **Saturday, May 14. Registration will last from 9 a.m. to noon** that day. There will be a brief **Parents Meeting at 10 a.m.**; please try to come if you can, especially if you are new to our team. For registration to be complete we need three forms, along with your fee: Swim Team Registration Form, RCSL City Meet waiver (even if you don't plan to swim City Meet), and RCSL Parent/Athlete Concussion form. All forms are found on the Swim Team page of the Greenwyche website. Please print and complete **ALL THREE** forms and bring them to the kick-off, mail to Lady Smith (1301 Forbes Dr., Huntsville, AL 35802), or bring the first week of practice.

The registration fee is \$60 for the first child, \$55 for the second child, and \$50 for the third child and beyond. (Make checks payable to Greenwyche Swim Team.)


